

You are advised to send intimations within the prescribed time to the Government of the amounts of each foreign contribution received by you, the source and manner in which the foreign contribution was utilised, as per the provisions of the FC Act, 1976 and the rules framed thereunder. An association is required to furnish the return even when the particulars are 'NIL'. The Bank Account mentioned in your application should be used for receiving foreign contribution and no other amount should be credited to the account. The Association should immediately intimate to this Ministry and obtain written confirmation regarding any change in the name of the Association, its address and Bank/Bank Account.

3. In case the association brings out any publication(registered under PRB Act, 1867) or acts as correspondent, columnist, editor, printer or publisher of a registered newspaper, at a later stage thereby attracting provisions of the Section 4(1) (b) of the FC(R) Act, 1976, the fact should be reported to the Ministry immediately.

4. You should also ensure before any funds are passed on to any person/association in India that the recipient is (i) eligible to accept foreign contribution under the Act, i

5. Failure to comply with any of the above provisions will make you liable for action under the provisions to Section 6(1) and/or under Section 23(1) of the Foreign Contribution (Regulation) Act, 1976.
